STUDENT EXPECTATIONS DURING VIRTUAL LEARNING

If a student does not abide by any of the following expectations, a classroom teacher may remove the student from their Zoom session and attendance will be marked accordingly.

- Students are required to comply with all District policies, school handbooks and teacher classroom directives while participating in remote instructional activities.
- Students should work in a quiet and private space while participating in remote classes to minimize potential disruptions from other sources (family members, television, pets, etc.).
- Students must dress appropriately for school when attending remotely; arrive on time for classes; remain for the entirety of their class schedule; and comply with log-in and log-out procedures when participating in remote classes.
- Remote students attending school must be prepared to participate and behave in class in the same exact manner
 as students who are in the classroom.

- Virtual classes are intended solely for the benefit of students permitted to be in attendance. Individuals who are not instructed to work remotely should not access, watch, observe or participate in those classes.
- The recording, downloading or copying of livestreamed classes for any reason in any format without the District's
 express written permission is strictly forbidden. Students will face school disciplinary consequences for violating
 this rule, and individuals who engage in such behavior may be referred to local law enforcement for the unlawful
 recording of other persons without their consent.
- Students or their parents/guardians must report any technology-related problems, as soon as they are discovered, so they can be identified and corrected. Students will not necessarily be excused from the potential consequences for missing classes, missing deadlines for the submissions of homework, assignments, etc. when technologyrelated problems are not brought to the District's attention within a reasonable period of time.

HEALTH & SAFETY MEASURES

- Parents must follow pre-screening guidelines at home before sending their students to school.
- Individuals are encouraged to wash hands frequently.
- Surfaces are cleaned, sanitized, and/or disinfected daily.
- Signage posted in schools will list the symptoms for COVID-19 and directions for what to do if exhibiting these symptoms.
- Students and staff should report to the nurse immediately if feeling symptomatic.
- A student or employee who presents with a fever of 100.4 or higher will be taken to an isolation area and parents will be notified immediately to pick up the child. The isolation area will not be in the nurse's office but in a separate area away from the main flow of traffic in the building.

WHAT ARE MY OPTIONS FOR TESTING IF I AM A CLOSE-CONTACT OR I AM EXPERIENCING SYMPTOMS?

- Receive a COVID-19 test from a hospital, medical office, or pharmacy.
 - o Students: Upon receiving results notify the student's building immediately.
 - Documentation of test must be provided.
 - o Staff: Upon results notify your supervisor immediately with documentation of the test result.
 - Documentation of test must be provided.
- Administer FDA approved COVID-19 home test.
 - Send the test result to the building principal.
 - Approved tests available at CVS, Walgreens, and Rite-Aid
 - Approved tests found at this site.
- Complete a test through MASD.
 - o Call the school hotline, 717-364-7711, to schedule an appointment.
 - A parent/guardian must accompany the student and bring the following items:
 - Driver's License
 - Insurance Card if individual does not have insurance, their test will be covered by the CARES Act.
 - The testing coordinator or designee will give a testing packet and instructions to the student or parent to administer from their vehicle.
 - o Parent will complete a testing form.
 - o Student or parent will administer the test and place it back in the bag.
 - o Parent will then be given printed instructions to find results on either the "My Quest App" or the Quest website.

COVID-19 THRESHOLD GUIDELINES FOR MASD

A maximum of 14-day suspension of in-person learning may be recommended by DOH if the following criteria are met:

- 5% of students/staff confirmed cases in 14-day window:
 - o Small school (<500 staff & students): 25 case threshold
 - Medium school (<500-900 staff and students): 25-45 case threshold
 - Large school (900+ staff & students): 45+ case threshold

OR

- 3 simultaneous classroom and/or core group outbreaks
 - Transmission between 2 or more students or students/staff/teachers without other identified epidemiological links in 3 or more classrooms and/or other core groups (i.e. teams, band)
